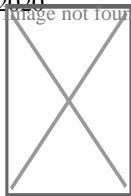

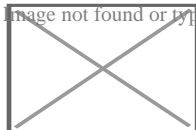

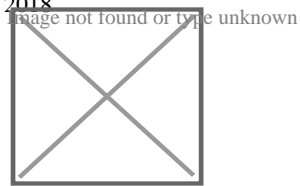
Arbitration Panel for In Rem Restitution: Application Processing Completed
